The general partner of Red Bird is Red Bird GP, Ltd. ("Red Bird GP") and the general partner of Blue Bird is Blue Bird GP, Ltd. ("Blue Bird GP"). The general partner of Green Bird is Green Bird GP, Ltd. ("Green Bird GP"). Apollo SVF Management, L.P. ("SVF Management") is the director of each of Red Bird GP and Blue Bird GP, and Apollo Value Management, L.P. ("Value Management") is the director of Green Bird GP. The general partner of SVF Management is Apollo SVF Management GP, LLC ("SVF Management GP"), and the general partner of Value Management is Apollo Value Management GP, LLC ("Value Management GP").
