Last week we announced a transaction that will transform Charter, giving us a greater concentration of operations in fewer states, improving our footprint and enabling us to better compete with the satellite and phone companies. This transaction includes acquiring systems from Comcast related to their pending acquisition of Time Warner Cable, transferring assets with Comcast, and taking an ownership position in a newly formed entity (SpinCo).

The decision to divest Charter systems serving approximately 1.6 million customers was difficult, and not taken lightly. We understand these transactions impact our employees and our customers. However, we strongly believe that realigning our systems is part of making us even more competitive, a better service provider and an even stronger company. Our employees and customers in systems being transitioned to Comcast become part of the largest company in the industry. We believe these transactions will benefit the entire industry and its customers.
