One third of the Restricted Stock Units will be first eligible to vest on each of the third, fourth and fifth anniversaries of the date of grant subject to achievement of the applicable per-share price hurdles. Any Restricted Stock Units that have not vested within 6 years from the date of grant will be cancelled.
- Withholding of securities for the purpose of paying taxes.
- Restricted Stock Units convert into common stock on a one-for-one basis.
